VI. HEALTH ATTESTATION / 卫生证明

I the undersigned official inspector authorised by the Swedish National Food Agency, certify that:

本人签署的官方检查由瑞典国家食品管理局授权，证明如下：

- 1) raw materials of the products come from a) country free from foot and mouth disease and of rinderpest or b) from administrative areas not subject to restrictive measures due to foot and mouth disease or rinderpest, confirmed by PRC. The country or regions are also free from brucellosis and tuberculosis during the past 12 months. The raw materials were obtained from healthy animals on the dairy farms on which there have been no occurrence of paratuberculosis and anthrax during the past 12 months.
